

HOLDINGS: [1]-A carrier's suit against the U.S. Department of Commerce, alleging that its strict liability interpretation of 15 C.F.R. § 764.2(b) was ultra vires under the 2018 **Export Controls** Act, 50 U.S.C.S. §§ 4801-4826, failed because the text of the Act firmly established that Commerce's interpretation of the statute and its regulation as allowing for strict liability was within its statutory authority, particularly as the Act itself omitted any mens rea requirement from its civil aiding or abetting prohibition, 50 U.S.C.S. § 4819(a)(2)(B); [2]-Further, circuit court precedent had upheld Commerce's attachment of strict liability in the regulation and there was an established rule of judicial deference to the Executive Branch in matters that involved foreign policy and national security.

Outcome
Judgment affirmed.

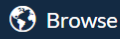
